## PRESIDENT'S REPORT

Mr. Andersen's report was dedicated to two public school teachers, Maxine Nolt, his aunt, who taught for 48 years and Margaret Mickleson who taught first grade for over 40 years. Mr. Andersen stated that teachers have always been a vital force in the country and have inspired each generation. From the perspective of the District 67 Board a commitment to maintain the tradition of outstanding teaching was recognized as a core value in the mission/vision work. Mr. Andersen thanked the teachers in the District.

## SUPERINTENDENT'S REPORT

Mr. Simeck reported that a school climate survey will be sent to all staff, families and students on January 20. Two weeks after the survey is closed the District will receive a detailed report that provides norming information with other schools. A

common survey, with standard questions, uniform across the shared services districts, will be done on a yearly basis and will allow for an action plan regarding specific issues.

## **Assessment Report**

Mrs. Fagel gave an overview of District 67 performance on ISAT and NWEA MAP assessments. In the future, academic achievement and growth data from standardized assessment will be presented in the larger context of the District Strategic Plan. A link to the Illinois Report Card is available on the District website.

## **English Language Adoption Report**

Mrs. Fagel, Ms. Milsk and Dr. Wilcox reported on the English Language Arts Adoption recommendation. The recommendation includes balanced literacy and workshops for reading/writing, ensuring that all students and teachers are moving in the same direction and that every student is getting the best education. The workshop model includes a mini lesson led by the teacher with independent student work in writing/reading. The workshop creates student ownership, develops and strengthens writing by planning, revising, editing, rewriting or trying a new approach. The program offers a year long, research based, naturally differentiated routine where students have extended time frames for research, reflection and revision. The theory is learning through doing. The anticipated implementation of the K-8 writing program is 2015-2016 and K-8 reading in 2016-2017.

North Suburban Special Education District - Mike Borkowski

Mr. Borkowski reported that the NSSED Governing Body met on December 10. The main topic was a vote on the proposed new billing structure. Mr. Borkowski discussed the District's dissatisfaction on issues including a desire to move to a payas-you-go structure, multi-year financial projections and a sensitivity analysis showing the effect of multiple districts withdrawing. The vote on the new billing structure passed. The Board agreed to work with District 67 on the issues.

## Curriculum Coordinating Committee - Lesley Fisher

Mrs. Fisher reported that the Curriculum Coordinating Committee met on December 4. Topics discussed included Atlas/Curriculum Mapping, the ELA adoption process, and world language programming. The World Language Committee is meeting monthly to develop belief statements, involve parents and bring the best thinking to ILT, CCC and the Education Committee and then to the full Board. An assessment of the World Language programming is taking place considering the decline in enrollment, very low class sizes for some languages currently offered and difficulties in staffing. Having a strong language program is the goal of the District.
